Call to Photographers Application for Entry

This application for entry, made and entered into this the _____ day of _____, 2011, by and between Preservation of Wilson (hereinafter referred to as the Foundation) and _____ (hereinafter referred to as "Photographers;")

Call to Photographers: Preservation of Wilson invites all photographers to enter a photo contest aimed at selecting the top (12) twelve photos to be included in the 2012 Preservation of Wilson Historic Porches Calendar.

The contest is open to all photographers, amateur or professional, working in any medium. Color or black and white photos may be submitted. Photos may be recently taken or a vintage photo. New photos must be set for the highest resolution the camera can take. The photos must be taken of a porch which is located in any one of the following historic districts.

A map is provided at the end of this document showing historic district boundaries.

Old Wilson Historic District	1850s – 1930s
Broad Kenan Historic District	1890s – 1938
East Wilson Historic District	1890s – 1941
West Nash Historic District	1900s – 1930s

The photo may be taken of the porch in any form, including, but not limited to, highlighting the architecture; porch life with family, friends or pets; focus on the beauty of one of the seasons; or any photo that can leave a lasting impression to the life of that particular porch. Please be respectful as to how close you get to the porch if you have not spoken with the owner.

Entry Fee: There is no entry fee.

Entry Deadline: July 31, 2011

Work is to be delivered, emailed or postmarked by midnight on July 31st.

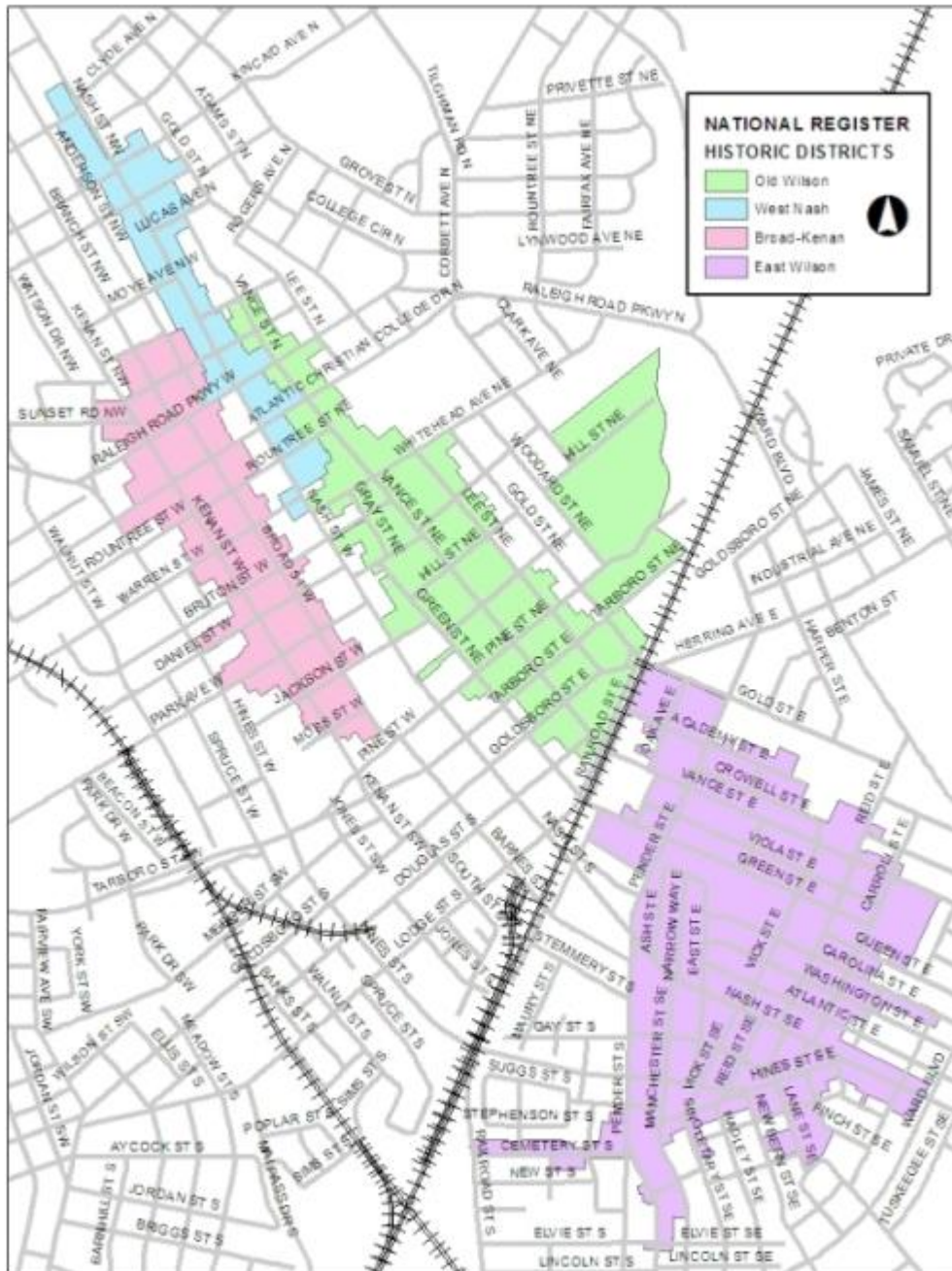
