Exhibition Contract

This contract made and entered into on the _____ day of _____, 2018, by and between Preservation of Wilson and _____ (hereinafter referred to as "Artist").

Exhibit period: Artist agrees to exhibit original artwork that has never been shown at a Preservation of Wilson Garden Party & Fine Art Show. The 2018 Garden Party and Art Show will be held in the garden of the Hackney House, 1120 Watson Drive between 4:30 p.m. – 6:30 p.m. This is an annual event in recognition of those supporting the work of Preservation of Wilson.

Entry Fee: A \$10 fee for submission for artist who are not already members of Preservation of Wilson. Memberships begin at \$25. Membership payment may be made by check payable to Preservation of Wilson or on-line at www.preservationofwilson.com.

Number of Entries: Each artist may submit up to five pieces of work and may include all these art pieces in one application.

Timeline:

April 6: Deadline to Return Submission forms with \$10 fee if applicable, along with a photo of work for social media

May 5th or earlier: Each Item must be delivered to Anne and Betsy to be displayed in the Art Show, along with a listed price and an easel for display.

Pick-up of work: Each artist will be responsible for removing any unsold items at the conclusion of the event unless otherwise negotiated with another artist. Preservation of Wilson is unable to be responsible for the safety of any and all artwork.

Inventory: Open to all artists working in any medium. Work must have never been shown before at a Preservation of Wilson Fine Art Show. Please provide an easel or stand for your work. Preservation of Wilson's Executive Committee retains the right to exclude individual pieces from the exhibition if offensive in any nature.

Inspiration: Let your wonderful North Carolina experiences be your inspiration!

Sale of work: All art pieces are available for sale with no commission taken by Preservation of Wilson. Artist will provide retail price for the piece submitted. None of the work submitted may be "not for sale." Payment will be made directly to the artist in cash or check. The committee chairs will handle the sale at the show and deliver checks or cash to the artist directly.

Insurance: Preservation of Wilson suggests that the artist insure their own work. There will be no additional insurance provided by Preservation of Wilson.

Promotion: Preservation of Wilson reserves the right to photographically reproduce work for promotional purposes and promote the exhibition as it deems appropriate.

Application Deadline: By April 6th a signed copy of this contract must be received by Preservation of Wilson, P. O.
